## PAUL E. YOUNG

Paul E. Young, 94, author of the book "Back Trail of an Old Cowboy," died Saturday evening, Oct. 4 at the Custer County Rest Home.

Mr. Young lived in the Miles City and Terry areas. He was born April 26, 1892 in Heber, Utah, a son of Olaf and Karen Edfors Young. He was educated in Park City, Utah.

After attending school through his sophomore year at Park City, he moved to the Four-Corner country where he worked for cattlemen. In 1912, when he was 20 years old, Mr. Young moved to Terry where he worked for his brother, Jim, tending bar at the West End Bar. He later worked for the Diamond A. and L.O. ranches. He broke horses for the government during World War I and later on the Big Dry in eastern Montana.

Mr. Young then homesteaded at Cherry Creek north of Terry, farming, raising and breaking horses.

He married Nellie May Gipson on Jan. 11, 1916 at Miles City. Five children were born to this union. On Sept. 13, 1943 he married Lydia White in Columbus.

In the late 1920s he operated the Dray and Ice Business in Terry. He sold the business in 1939.

In 1936 Mr. Young traded horses for land, a cabin and artesian well south of Terry on the Powder River. He developed these holdings into a large ranch which was sold in 1977 to the Diamond Ring Ranch. While on his ranch, Mr. Young raised registered black Angus cattle and quarter horses. Mr. Young

moved to Miles City, but stayed actively involved with the horse business until the time of his death.

He was a charter member of Range Riders, Inc. and the Elks.

He moved to the Custer County Rest Home in 1982 because of surgery and failing health. His book was released in 1983.

His survivors include three sons, Alvin L. and Eugene E. both of Alzada and Glen E. of Belle Fouche, S.D.; a daughter, Lila L. Hewett of Tacoma, Wash.; 10 grandchildren, 18 great-grandchildren; and 5 great-great-grandchildren.


He is also survived by two sisters, Vivian Trenouth of Sun City, Ariz. and Freda Dunning of Ojai, Calif.; and numerous nieces and nephews.

Mr. Young was preceded in death by one son, Chester; one brother, Jim; and four sisters, Nellie, Helen, Hilma and Nina.

Prayer services will be held at 7 p.m. Tuesday, Oct. 7 in the chapel of Stevenson and Sons Funeral Home.

Funeral services will be at 2 p.m. Wednesday, Oct. 8 in the funeral home chapel. The Rev. James Schoeld will officiate. Mr. Young will be taken from the funeral home to the city limits of Miles City by horse-drawn hearse. Burial will be in the Prairie County Cemetery at Terry.
